### **URC Spring Show Team**

***Riders in this program should be preparing or ready to attend horse shows!*** Groups meet/ride every other **Friday; 4 riding lessons, 2 unmounted instructional per quarter**

**Pre-showing** - Students Intermediate B and below preparing for but not yet showing. Group limit 7

**Level 1** - Students in Lessons Intermediate B and below; actively starting to show: leadline up to 2' Hunters. Limit 6

**Level 2** - Students in lessons Intermediate B and below; able to show at .70m Jumpers or 2'3" Hunters & Up. Must own/full lease own horse to compete above 2'3". Limit 6

 For all programs, riders Intermediate level and above and adult riders groom & tack up their horses. Please plan to arrive 30 mins before the lesson to be ready to begin on-time 😊 Thank you!

### **Missed Lesson Policy - please review - thank you!**

Class space is held, our horses and staff are here ready for your/your rider's attendance! Notice must be given at least 24hrs in advance of a missed lesson to be eligible for a make-up practice ride. Missed lessons are made up as independent practice rides. (Contact the business line to schedule.) Beginner A/A+/B students not ready for practice rides: we will roll over credit to the next quarter for up to two missed lessons per quarter. **Initial:** \_\_\_\_\_

### **Weekly Group Lessons - Ages 6 and Up**

**12 Lessons: \$575 (credit card/QBI/Venmo/Pay App); \$550 (cash/check) for 12 weekly lessons in a 3-month Quarter**

- o Lesson blocks are 45 minutes to one hour of instruction; lessons include time for mounting and adjusting tack.
- o Beginner A & A/A+/B lessons normally limited to 6 riders and attended by ring assistants, as needed.
- o One lesson per quarter may be unmounted to teach horse care, tacking, grooming, handling etc.

## **Lessons + RideShare Leasing - over age 10 + instructor approval**

- **Spring Quarter leasing is 12 weeks from February 26<sup>th</sup> to May 19<sup>th</sup>**
- **Leasers may do flat and work over ground poles during regular lease rides**
- URC must utilize horses as needed for our lesson program and always has priority over horses. **A lease horse cannot be guaranteed available for all lease rides or lessons; students will always have the option of riding a different horse appropriate for their level!**
  - Text to the business line: (240) 877-4686 to confirm each lease ride (24hrs in advance is helpful for our planning!)
  - Riders, please check the lesson board before beginning a ride. Horses may not be used within 1.5 hours of a lesson. We try to post lease ride times along with the lesson lists.
- Horses will generally be in the barn from 9:00 am to 4:00 pm
- If coming for a ride when horses are turned out, leasers may need to bring in their horse from the field!
- Riders must generally participate in 12 lessons at URC, be at "Beginner C" level or above to be approved for leasing
- Horses' break week is: 05/20/24- 05/26/24 - lease riders are welcome to groom/graze and visit them!
- **Missed lease rides are not eligible for 'make up' or roll-over to another week or quarter**

**RideShare Leasing Agreement for Quarterly Program:** *I understand this is an unsupervised ride program and will accept all the risks of a rider as if this were my/my child's own horse.*

**Any child under the age of 13 must be accompanied by an adult guardian at all times** and no one is permitted to ride without another person present in/around the rings/trails/barns.

**Riding should be limited to 45 minutes total** and include proper warm up and cool out.

**Students are not permitted to jump unless participating in the supervised jump/lease rides.**

Leasers may not trade horses, nor allow any other student, leaser, or boarder on 'their' horse during the scheduled lease ride. All school tack should be put back after use on the appropriate racks, neatly.

**All other leasing rules listed on the website and posted facility riding rules apply.** *I/we will any report injury or illness exhibited by the horse immediately. I/we understand there is no riding off URC property for any reason, no riding in barn aisles. If RideShare rules are violated; URC staff will issue a verbal warning. After the verbal warning, a second offense will result in a written warning, issued via text/email. After the initial written warning, a violation of RideShare rules will result in a final written warning via email. After the third and final warning, a violation of RideShare Rules will result in the student's immediate removal from the RideShare Program with no refund. URC reserves the right to remove a student from the RideShare program, for any reason, without warning or refund.*

## **URC Show Team - Levels Pre-Show, 1 & 2 - Young and Adult Riders ready and preparing for horse shows**

- **Quarterly tuition: \$300\*** (cash/credit, add 5% for credit cards/QB/pay apps)
- **Intended for riders with near term showing goals (not just extra riding lessons 😊)**
- **Group Space is limited: Pre-Show - up to 7 riders, Levels 1 & 2 - up to 6 riders each**
