- ❖ **Summer Quarter leasing 12 weeks: RideShare A & B, Levels I & II, III, Premium Horses & Evolution Leases**
 - ❖ **Leasers may do flat and work over ground poles during regular lease rides**
 - ❖ Text the business line: (240) 877-4686 to confirm each lease ride; during camp weeks horses are 'off' Sundays.
 - ❖ Riders must have participated in a full quarter of lessons and be in weekly lessons at Beginner C or Level II or with instructor permission, and have a demonstrated ability to catch/turn out, groom, tack and safely handle the lease horse.
 - ❖ Lease horses are not guaranteed available for all lease rides or lessons; riders always have the option of riding a different horse appropriate for their level!
 - ❖ **Missed lease rides are not eligible for 'make up' or roll-over to another week or quarter**

Leasing Agreement for Quarterly Program: *I understand this is an unsupervised ride program and will accept all the risks of handling and riding as if this were my/my child's own horse.*

Any child under the age of 13 must be accompanied by an adult guardian at all times. *No one is permitted to lease ride without another person present who has sight of the rider in/around the rings/trails/barns.*

Riding should be limited to 45 minutes total *and within the hour, include proper warm up and cool out.*

Students are not permitted to jump unless participating in supervised jump/lease rides.

Leasers may not trade horses, nor allow any other student, leaser, or boarder on 'their' horse during the scheduled lease ride. All school tack should be cleaned and put back after use in the appropriate locker, trunk or racks, neatly.

All other leasing rules listed on the website and posted facility riding rules apply. *I/we will any report injury or illness exhibited by the horse immediately. I/we understand there is no riding off URC property for any reason, no riding in barn aisles. If leasing rules are violated; URC staff will issue a verbal warning. After the verbal warning, a second offense will result in a written warning, issued via text/email. After the initial written warning, a violation of leasing rules will result in a final written warning via email. After the third and final warning, a violation of Leasing Rules will result in the student's immediate removal from the Leasing Program with no refund. URC reserves the right to remove a student from the Leasing program, for any reason, without warning or refund.*
